SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If on skin

If in eyes

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person. SECTION 7: Handling and storage

7.1. Precautions for safe handling

Prevent formation of gases and vapours in flammable or explosive concentrations. The product should be used only in the areas where it is not in contact with open fire and other ignition sources.
