SECTION 4: First aid measures

4.1. Description of first aid measures

Do not perform artificial respiration without self-protection (e.g. a mask). Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If unconscious, put the person in the stabilized (recovery) position on his side with his head slightly bent backwards and make sure that airways are free; never induce vomiting. If the person vomits by himself, make sure that the vomit is not inhaled. In life threatening conditions first of all provide resuscitation of the affected person and ensure medical assistance. If on skin

Remove contaminated clothes. Wash the affected area with plenty of water, lukewarm if possible. Soap, soap solution or shampoo should be used if there is no skin injury. Provide medical treatment if skin irritation persists. Rinse skin with water or shower.

If in eyes

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person. Rinsing should continue at least for 10 minutes. Provide medical treatment, specialized if possible.

If swallowed

If the affected person vomits, make sure to prevent inhalation of the vomit (as there is a danger of lung damage after inhalation of these liquids in the airways also in infinitesimal amount). Provide medical treatment considering the frequent need of further observation for at least 24 hours. Bring an original container with the label and the Safety Data Sheet of the given substance as appropriate.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Provide sufficient ventilation. The substance is flammable. Remove all ignition sources. Use personal protective equipment for work. Follow the instructions in the Sections 7 and 8. Do not inhale mist/vapours/spray. Prevent contact with skin and eyes.
