SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. Rinse out the mouth with water and provide 2-5 dL of water. Provide medical treatment if the person has any health problems.
